The Sponsorship Agreement

This Sponsorship Agreement (the "Agreement") is entered into effective as of the date set forth on the signature page hereto (the "Effective Date") by and between the Capes & Crowns Fun Run and 5K event organizers operating within the organization The Tree House Episcopal Montessori School, a Florida non-profit group with 501c3 status (hereon forth referred to as the "The Tree House") and the sponsor set forth on the signature page hereto ("Sponsor"). In consideration of the mutual covenants contained herein and for other good and valuable consideration the parties hereby agree as follows:

1. SPONSOR DELIVERABLES

- a. Sponsor Payments. Sponsor will provide sponsor donation to The Tree House upon commitment to sponsorship. In-kind donations will be arranged by The Tree House on a case-by-case basis.
- b. The Tree House has permission to use of Sponsor Name and Logos for event and include on all pre-approved marketing materials related to the event. Sponsor grants The Tree House the non-exclusive right to use the Sponsor name and logos as part of press releases, marketing, advertising, and promotional materials solely in connection with the Capes & Crown Fun Run and 5K event project. Any such use shall be subject to Sponsor's prior review and written consent. Sponsor reserves all rights not otherwise expressly granted herein. The license gives The Tree House limited rights to use Sponsor's name and logos. The Tree House does not become the owner of, and Sponsor retains title to, such Sponsor names and logos.

2. 30A10K DELIVERABLES

- a. The Tree House Deliverables. The Tree House will deliver the appropriate sponsorship level promised items (see sponsorship packet).
- b. Sponsor Use of The Tree House Name and Logos. The Tree House grants Sponsor the non-exclusive right to use the Capes & Crown Fun Run and 5K name and logos as part of press releases, marketing, advertising and promotional materials solely in connection with Sponsor's sponsorship of The Tree House for the 2015 race. Any such use shall be subject to The Tree House's prior review and written consent. The Tree House reserves all rights not otherwise expressly granted herein. The license gives Sponsor limited rights to use The Tree House's Capes and Crowns Fun Run & 5K name and logos. Sponsor does not become the owner of, and The Tree House retains title to, such The Tree House/ Capes & Crowns Fun Run and 5K's name and logos. The foregoing license specifically excludes any right to use of The Tree House name or logos in any series of Sponsor's products or services or for similar commercial purposes, and the parties may enter into a separate agreement on mutually acceptable terms with respect to any such commercial rights.

3. CONFIDENTIALITY

Each of the parties (the "Receiving Party") shall maintain the confidentiality of this Agreement and all confidential information of the other party (the "Disclosing Party") and shall not release, disclose or divulge any such confidential information without the prior written consent of the other party prior to the event date or prior information released to the media. The Receiving Party may only use and copy such confidential information as is necessary to carry out its activities contemplated by the Agreement (but subject to the provisions thereof) and for no other purpose. The Receiving Party may disclose confidential information to its employees, personnel, subcontractors and representatives on a "need to know basis", provided that it shall first instruct such employees and personnel to maintain the confidentiality thereof. A Disclosing Party's confidential information shall not include information that: (a) is or becomes a part of the public domain through no act or omission of the Receiving Party; (b) was in the Receiving Party's lawful possession prior to the disclosure and had not been obtained by the Receiving Party either directly or indirectly from the Disclosing party; (c) is lawfully disclosed to the Receiving Party by a third party without restriction on disclosure; (d) is independently developed by the Receiving Party; or (e) is required by applicable law to be disclosed.



Signed Sponsorship Agreement

This Agreement, including any exhibits hereto, contains the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior negotiations, representations and proposals, written or oral, relating to such subject matter. No supplement, modification or waiver of this Agreement shall be binding unless executed in writing by both parties.

Proceeds from the 2015 Capes & Crowns Fun Run and 5K event will benefit The Tree House Episcopal Montessori School.
